## Corporate Statement


To whom it may concern

The General performance interval of the Dr. Schutz PU SEALER system is between 3 and 10 years depending on specific project circumstances such as traffic, quality of applied entrance mat systems, anti-scratch furniture protection, floor and building maintenance.

The warranty time for a surface coated with the Dr. Schutz PU SEALER system is 2 years. The warranty is only valid on the following conditions:

1. The application of the Dr. Schutz PU system took place on a suitable sub-surface, tested by the person carrying it out (applicator).
2. The application took place in compliance with all the technical information of Dr. Schutz (product information, instructions for use).
3. On-going cleaning and care are performed using professional cleaning tools and machinery and Dr. Schutz "PU Cleaner". Further measures for renovation and maintenance (such as anti-dirt mats and furniture gliders) are to be carried out by the client according to Dr. Schutz care instructions for surfaces supplied by the applicator, specific to the building where floors have been coated with Dr. Schutz PU Sealer.
4. Local damage (such as deep scratches) caused by sharp items are not covered by this warranty.

The warranty can be renewed after years by renovation of the surface using the Dr. Schutz PU SEALER system again.
